 - (1) Quality of life issues here while balancing the other issues throughout the city.
 - (2) What does the relationship between RUPD and CCPD look like to maintain this balance?
 - (a) Open lines of communication.
 - (b) Communication path needs to be maintained.
 - (c) Lt. Giannini looking to have an instrumental transition.

viii. Recent:

- (1) Robbery of 69 year old woman at 3rd and Market, possibly around 10:30pm. Was assaulted upon trying to defend herself. Description of male very basic.
 - (a) Walk at highly lit areas
 - (b) Try not to defend too much, avoid injury.
- (2) Looking to have bike patrols depending on weather and personnel.
 - (a) Working their way from Broadway corridor?
 - (i) Based off of the crime plan/real time crime reporting. If there is an increase in crime predicted, there will be an increase of bike patrol and patrol in general.
- (3) Are there hotspots we can focus on to avoid dispersion of crime? Is there something that the community can participate in?
 - (a) North Camden crimes seem to be staying in North Camden. Crime in North Camden almost at an all time low.
 - (b) Just reporting any issues.
- (4) CVS parking lot has active drug activity... is it allowed? How can we address it?
 - (a) Sgt. Watkins platoon speaks for his platoon when he says it is not accepted during their shifts.

- a. Cooper Street Interpretive Committee mtg Cooper Street festival
 - i. Looking for possible grants to fund projects on Cooper Street.
 - (1) Fairs
 - (2) Looking to do a one-time event
 - (a) Opening the doors to Rutgers on Cooper Street to liven up the street.
 - (b) Opening some houses.
 - (i) Writer's House
 - ii. Cooper Ferry started it, head of MARCH (Mid-Atlantic Research Center for the Humanities located at 325 Cooper Street) now spearheading this initiative.
 - iii. Meet about every month, Ben thinks meetings are open.
 - iv. Shawn wrote a letter asking for ideas.
 - v. Graham Alexander potentially transitioning to Camden, could open door to much history of recorded sound in Camden
 - vi. September timeframe for redoing Cooper Street, making it more usable... basically 7th-4th streets.
 - (1) American Water coming in around the same time (900 employees, with about a 400 car garage) as when construction starts.
 - (a) What do we do?? John attends CIA meetings (Community Improvement Agreement). Liberty Property Trust has these meetings. Invited someone to talk about the options for transportation for the employees and speak with us about what it will look like at next month's meeting. Prep questions!

- a. 320 N. 2nd Street
 - i. Did talk to Ian: We will work with him to discuss
 - ii. Pastor of church was asked by Mayor about fence, turning into the conversation about the park and the construction of the park.
 - iii. A dog park is a no go based off of neighbor feedback.
 - iv. Cooper's Ferry gave the OK for the mural as long as CRA and church are OK with it.
 - (1) Needs to include the values of the church (but also the neighborhood).
 - (2) Pastor wants to chat with Vedra as well in order to determine the best option.
 - (3) Think about the unintended consequences
 - (a) i.e. picnic tables could lead to public drinking and loitering.
 - (4) Options may include:
 - (a) adopt the lot
 - (b) raised beds
 - (c) game court
 - (d) art box
 - (e) sculptures
 - v. Mural piece
 - (1) Camden Art Gardens program, Connect the Lots and Rutgers.
 - (2) Has to be visible for some time
 - (3) CRA approval
 - (4) No development planned
 - (5) Planned with a contracted, professional artist.
 - (6) Two lots need to be identified to apply.
 - (7) Cost \$15,000 over 15 workshops.
 - vi. If we had a dog park, where would we put it?
 - (1) Cooper Poynt park
 - (2) Baseball field
 - (3) DRPA land tracks by the bridge

 - i. Open conversation about parking

- ii. Some neighbors say people are skating laws at 1 hour parking.
 - (1) Do we remove 1 hour ordinance where there are homes, and leave the other?

d. Development Committee Report

- i. M&M Partnership @ The Pierre building
 - (1) Sidewalk issue has been discussed. Need to fix infrastructure prior to fixing sidewalk.
- ii. Liberty Property Trust waterfront updates
 - (1) They do not run the parking garage building.
 - (2) 11 stories on top of the 7 story parking structure.
 - (3) NFI and Michael's building
 - (4) Housing is moving forward. Dranoff not involved. 180 apartments in an L shape at Cooper and Delaware.
 - (5) New hotel plan under new footprint is at the end of Penn Street. Working on buildings surrounding.
 (a) 1.5 years left.
 - (6) Bike ramp closed for 14 months now. North side is open now.
- iii. ABC Barrel Factory lot
 - (1) No update.
- iv. Tree Planting:
 - (1) Saturday, May 5th in the morning.
 - (2) Some money from Green Way Grants
 - (3) About 15-20 trees needed.
